## Application for Sewer Service

The undersigned hereby makes application for sewer service provided by Lincoln County Board of Public Utilities (LCBPU) and agrees to pay for said sewer service as measured by the LCBPU's water meter and billed according to applicable sewer rates. Payment for sewer service shall be made in accordance with standard billing and collecting procedures of LCBPU.

The applicant agrees that this application and the sewer service rendered here under are subject to the LCBPU's schedule of rules and regulations and further agrees that the LCBPU's rules and regulations are part of this application for sewer service. This applicant also agrees that if it becomes necessary for LCBPU to commence legal proceedings to recover payment for sewer service, applicant is liable for all expenses incurred including but not limited to, collection expense, attorney's fees and court cost. Applicant is aware that theft of sewer service may subject the customer to civil and/or criminal liabilities.

The applicant agrees that (1) The applicant grants right of ingress and egress by LCBPU employees to service LCBPU property located on said premises; (2) Applicant further agrees to notify LCBPU three days before vacating said premises or discontinuing service for any reason; and (3) LCBPU shall have the right to discontinue service without further notice in case of applicant's failure to comply with this agreement or any part thereof or failure to make payment as set out above.

Applicant/customer agrees to pay or make satisfactory arrangements to pay all outstanding amounts due to LCBPU before any services will be connected and further agrees to the discontinuance of any service being provided upon the failure of applicant/customer to pay any sum due and owing to LCBPU arising from the provision of any service or from damages caused to any LCBPU property.

Applicable sewer rates and statement of nondiscrimination are available at the LCBPU's web site and main administrative office location. Applicant agrees that the premises covered by this application will be plumbed in accordance with the specifications and regulations enacted by LCBPU and the State of Tennessee.

\_\_\_\_\_(initial) Acceptance of services provided by LCBPU shall constitute consideration for and acceptance of the terms of this agreement.
