Application for New Service Tap or Set Meter

The undersigned hereby makes application for a New Service Tap provided by and installed by Lincoln County Board of Public Utilities and agrees to pay for said Service Tap according to applicable utility rates.

The APPLICANT agrees that this application and the service tap rendered are subject to LCBPU schedule of rules and regulations and further agrees that the LCBPU rules and regulations is part of this application for the installation of a Service Tap.

The APPLICANT agrees that (1) LCBPU shall retain title to service tap, meter, and all parts required to install a tap, (2) applicant shall be responsible for the safekeeping of all property of LCBPU on said premises, (3) applicant grants the right of ingress and egress by LCBPU employees for the purpose of inspecting, examining, repairing or removing LCBPU property on said premises.

The tap owner or consumer is required to lay, at own expense, and to own and maintain service lines, pressure regulators, and all other fittings required on said property beyond the meter. Customer is responsible for any leak repairs or water loss incurred past the meter set.

If for any reason the APPLICANT does not connect to the LCBPU's water system, the APPLICANT agrees to pay monthly minimum bill at current rates until at such time ownership of the property on which the tap is located is transferred to another individual whether it is an individual, partnership or corporation.

Installation of New Service Tap fees are set by LCBPU as follows:

INSTALLATION OF:

¾ Inch Tap	\$1,600 plus application for service, deposit as required & Capacity Fee	\$1,400 when set as "Dry Tap" without meter (for developers only) Capacity Fee is required
1 Inch Tap	\$2,000 plus application for service, deposit as required & Capacity Fee	\$1,800 when set as "Dry Tap" without meter (for developers only) Capacity Fee is required
¾ Inch Tap For Irrigation	\$1,000 when yoked, plus application for service, deposit as required & Capacity Fee*	

Request for larger service tap requires approval by LCBPU and will be priced accordingly.

New Service Tap includes up to 60 feet of service pipe. Any pipe over 60 feet will be an additional cost of \$5 per foot. Customers applying for a tap that requires the boring of a 4-lane state highway will be required to contact a contractor for this work at own cost. This cost is not a part of LCBPU service tap fee. LCBPU reserves the right to refuse any new service taps.

SET METER:

Set Meter at **new service address** that has TAP but no AMI meter and has not had prior service; \$200 meter fee plus application for service, service charge and deposit as required.

*Irrigation taps are subject to 50% Capacity Fee due to being seasonal
